

MEMORANDUM OF UNDERSTANDING (MOU)
between
Columbia Institute of Pharmacy, Raipur
and
Pt. Jawaharlal Nehru Memorial Medical College, Raipur.

PREAMBLE

With the recognition of their strengths in research in one or more disciplines of science and their mutual interest in engaging themselves in research/academic cooperation, Columbia institute of Pharmacy Raipur and Pt. Jawaharlal Nehru Memorial Medical College Raipur agree to establish a program for research/academic cooperation in areas of mutual interest and in accordance with terms and conditions set forth in this memorandum of understanding (MOU). This MOU entered into and executed on 3rd March 21 between Columbia Institute of Pharmacy Raipur and Pandit Jawaharlal Nehru Memorial Medical College Raipur.

Columbia institute of pharmacy, Raipur is the first party and Pandit Jawaharlal Nehru Memorial Medical College, Raipur is second party in this MOU.

Objectives

The goal of this cooperation is to foster academic and research collaboration, provide opportunity for global experience and to facilitate advancement of knowledge on the basis of reciprocity, best effort, mutual benefit and frequent interactions. Medical College Raipur and Columbia Institute of Pharmacy Raipur agree:

- a) To jointly propose and engage in research or training programmes as per National priorities sponsored by funding agencies, and to invite each other scientists and faculty to participate therein.

- b) To exchange the information on research and education programs, teaching, learning material and other literature, with dual approval of the competent authority of both the organizations.
- c) To jointly organize short-term continuing education programs on topics of mutual interest and to invite each other's scientist/faculty to participate there in.
- d) Jointly organize seminars, conferences or workshops on topics of mutual interest and to invite each other's scientists and faculty to participate therein.
- e) To exchange, on a reciprocal basis, students/scholars for limited periods of time for purpose of education and/or research.
- f) To encourage any other academic/research activities that both the institutions agree to be on mutual benefit.

Medical College Raipur and Columbia Institute of Pharmacy Raipur agree that detailed terms and conditions that guide each activity identified above will be separately determined and agreed upon by the two institutions. These terms shall include a technical description of proposed activity, financial arrangements, and person(s) responsible for its implementation, etc.

B. Joint sponsored research development and consultancy

Medical College Raipur and Columbia institute of pharmacy Raipur agree to help identify and invite scientists/faculty members from the other institution to participate in research or development programs already sponsored as well as new proposals by external funding agencies. The terms and conditions for such participation will be worked by mutual agreement between the scientist faculty members and the institution extending such an invitation. Data generated through such collaborative research shall be published in scientific journals jointly, with due approval of the competent authorities of both the institutions. When a scientist/faculty member



visits the other institution on invitation or as part of such joint research project, then such a visit will be classified as such, and handled as per rules of the individual institution.

C. Exchange of faculty scientists staff and students

Medical College Raipur and Columbia institute of pharmacy Raipur agree to encourage collaboration between faculty and scientists from the two institutions. Specifically, the institutions will encourage members of their scientist/faculty to undertake short visits to and take up fixed-term visiting assignments at each others institutions. The terms and conditions for each visit or an assignment, including those concerning stipend, travel and housing will be worked out between the concerned scientist/faculty members. Students and staff may exchange between both the institutions for R&D and academics.

D. Exchange of scientific and technical material

Medical College Raipur and Columbia institute of pharmacy Raipur will exchange information on research and educational programs, teaching, learning material and other literature, relevant to their educational and research programs, with due approval of the competent authority of both the organizations. Further Columbia institute of pharmacy Raipur and Medical College Raipur agree to explore ways to share teaching material, and other relevant literature, while respecting each other intellectual property and other rights.

E. Joint conferences workshops and short term courses

Medical College Raipur and Columbia institute of pharmacy Raipur agree to help identify and invite scientists/faculty members from other institutions to participate in conferences workshops and short term courses. The terms and conditions for such participation will be worked out by mutual agreement between the invited scientists/faculty member and the institution extending



such an invitation. When a scientist/faculty member visits the other institution on invitation or as part of such joint activity/research project, then such a visit will be classified as such and handled as per rules of the individual institution.

F. Intellectual property

Medical College Raipur and Columbia institute of pharmacy Raipur agree to respect each other's rights to intellectual property. Further, the intellectual property rights that arise as a result of any collaborative research or activity under this MOU will be worked out on a case to case basis by the competent authorities of both the institutions, and will be consistent with officially laid down IPR policies of the two institutions.

H. Tenure and termination

1. This MOU will take effect from the date it is signed by heads of Columbia institute of pharmacy Raipur and Medical College Raipur.
2. This MOU may be amended at any time by Written mutual consent of the competent authorities from both institutions.
3. Either institution may terminate the MOU by giving written notice to the other institution, not less than six months prior to the termination date. However, Columbia institute of pharmacy Raipur and Medical College Raipur agree that all on-going research/activities



are allowed to complete successfully, and obligation of the funding bodies, if any, are met in full, subsequent to the notice of termination.

4. The termination of this MOU shall not affect the rights or obligations of either institutions regarding any binding offer or from obligation approved and agreed to either institution prior to the termination date.



J. Arbitration clause

In event of any disputes arising between Medical College Raipur and Columbia Institute of Pharmacy Raipur hereto, it shall be endeavor of Principal, Columbia Institute of Pharmacy Raipur and Dean, Medical College Raipur to first make an attempt to resolve the dispute amicably by mutual discussion and deliberations in a spirit of independence, mutual respect, and shared responsibility, failing which the disputes shall be referred to Arbitration. The Arbitration shall be conducted as per the provisions of Arbitration and conciliation act 1996. The arbitral tribunal shall consist of a Sole Arbitrator to be appointed mutually by both the institutions. The award of the Tribunal shall be final and binding on both the institutions.




