



Memorandum of Understanding  
Between  
BURAPHA UNIVERSITY, THAILAND  
and



COLUMBIA INSTITUTE OF PHARMACY, INDIA

To formalize the friendly relationship between **Burapha University** (hereinafter referred to as “BUU”) whose address for purpose is at Burapha University, 169 Long-Haad Bangsaen Road, Saen Sook Sub-district, Muang District, Chonburi Province, Thailand as one party and **Columbia Institute of Pharmacy** whose address for purpose is at Village Tegari, Post-Girod, Near Vidhan Sabha, Raipur (C.G.) 493111, India, as the other party, both universities are parties to a sister-university agreement entered for the purpose of encouraging research, education programs, and the exchange of faculty, students, and staff of both institutions. This purpose is designed to serve the mutual interests of both institutions.

**ARTICLE 1: AREA OF COOPERATION**

1. Visiting and exchanging of research scholar students, graduate students, faculty and administrators for study and research in accordance with regulations of both government and universities.
2. Developing joint research projects and joint publications.
3. Cooperation in individual projects.
4. Organization of lectures, symposia, international meeting/conference/workshop.
5. Providing opportunities for senior faculty of both universities to deliver invited guest lectures at each other universities.
6. Searching for opportunities to collaborate in the future.

In order to promote cooperation and the advancement of academic and educational exchanges.

**ARTICLE 2: NON-BINDING LEGAL AND FINANCIAL**

This Memorandum of Understanding (MOU) is intended only to set forth the general understanding of the parties with respect to the subject matter herein, and does not intend to, contractually bind the parties, neither in term of legal nor financial obligation. The parties may enter into other agreements to achieve the purpose of this MOU.

**ARTICLE 3: VALIDITY, AMENDMENT AND TERMINATION**

The term of cooperation for each specific activity contemplated under this Memorandum of Understanding shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity. Any such activities agreed upon will be recorded and governed by a separate legally binding agreement executed by both parties. Each institution shall designate a liaison officer to develop and coordinate the specific activities agreed upon. This memorandum of understanding imposes no financial obligations on either party. Both institutions understand that all financial arrangement will have to be negotiated and will depend on the availability of funds.

This memorandum of understanding will remain current for five (5) years after it is signed by both parties and is renewal by the mutual consent of the parties. It may terminate at any time by mutual consent or by six (6) months' notice in writing by either party and is renewal by the mutual consent of the parties.

Each party shall not make any public announcement or statement or publish or release any information in relation to any proposed activity or proposed collaboration without the prior written approval of both parties. Each party shall keep confidential any information that it receives from the other party which is marked confidential or which a party as confidential.


